Management reserves the right to alter, change, modify or discontinue any membership programs and renewals.

By signing below:

- **Applicant(s)** agree that they are individually responsible for any charges made to their House Account by each other, any of their dependents, and any guests.
- **Applicant(s)** agree this is an annual membership fee, payable in the installments noted in your payment method. If you do not pay any installment of your annual membership fee or do not pay your House Account when due, Griffin Gate Golf Club may demand that you pay the entire balance of the annual membership fee in addition to your House Account within 30 days. Should the Applicant(s) become delinquent on their payment or violate any of the *Membership Policies and Rules*, then Applicant(s) understands and agrees that they will pay interest on the unpaid balance at 10% per annum from the due date until paid.
- **Applicant(s)** understands and agrees that they shall be placed for collection and be responsible for any court costs, collection fees, and attorney fees incurred by Griffin Gate Golf Club, in addition to the full amounts owed to Griffin Gate Golf Club. Demand for payment shall be delivered to you on the date Griffin Gate Golf Club mails the demand to the address on your application, or such other address you provide in writing. GRIFFIN GATE GOLF CLUB CODE OF CONDUCT

1. Show up 30 minutes prior to your tee time. Give yourself time to check in the golf shop, purchase any food and beverage and warm up prior to play.
2. Please note that the club enforces a dress code policy. Denim, cutoffs and short shorts are prohibited. Men are required to wear a collared shirt.
3. Outside alcohol and/or coolers **are not permitted** at Griffin Gate Golf Club per Kentucky State Law. The Golf Club's liquor license requires that beverages only be dispensed by Golf Club employees or bartenders. Alcoholic beverage service may be denied to those guests who appear to be intoxicated or are under age. If there is any evidence of outside alcohol brought to Griffin Gate Golf Club, a **\$500.00** penalty will be billed to the credit card on file. We appreciate your compliance with these standards and abiding by Kentucky ABC Laws.
4. Golfers are to tee off in groups of 4 players or less. Groups of 5 or more are not permitted at any time.
5. After 9 holes, please order any food and beverage quickly as to not create a backup on Hole #10.
6. Our standard pace of play is 4 hours and 20 minutes for 18 holes, or 2 hours and 10 minutes for 9 holes. Please keep up with the group in front of you and play ready golf. Fellow members and hotel guests will appreciate it.
7. When on the course, please fill in any divots on the tee boxes, fairways and rough areas with the sand bottles conveniently located on your golf cart. When you come up to each green, please repair your ball marks.
8. We want you all to have a wonderful time, however please be respectful of your golf cart, the golf course grounds and those golfers who are not in your group.
9. Loud music is not allowed. If playing music, the volume should not be loud enough for other golfers to hear.
10. Use of the golf course is subject to compliance by golfers with the rules and regulations for use of the golf course, club house, practice facility, golf carts and other facilities as set forth from time to time by management agreement of Griffin Gate Golf Club. In particular, golfers must follow all signage, are expected to maintain pace of play, fix all divots and ball marks, and refrain from inappropriate behavior towards Griffin Gate Golf Club patrons or staff members deemed unacceptable by the Griffin Gate Golf Club management team. It is agreed that failure to follow the above could result in suspension or full loss of golfing privileges the day of play and in the future. A loss of such privileges will be at the sole discretion of the management of Griffin Gate Golf Club. If such loss occurs, no payment under this agreement will be refunded.
